

Salishan Wedding Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE IN THIS CONTEST. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

YOU WILL ONLY BE ENTERED IF YOU FULLY COMPLY WITH THESE OFFICIAL RULES AND ALL INSTRUCTIONS FROM SALISHAN RESORT (“SPONSOR”), ITS DIVISIONS AND RELATED ENTITIES, AND EACH OF THEIR REPRESENTATIVES.

WINNER(S) WILL BE REQUIRED TO RESPOND TO WINNER NOTIFICATION AND OTHER COMMUNICATIONS FROM SPONSOR (DEFINED BELOW) WITHIN THREE (3) DAYS ACCORDING TO THE NOTICE(S) FROM SPONSOR OR PRIZE MAY BE FORFEITED (IN SPONSOR’S SOLE DISCRETION).

BY ENTERING THIS CONTEST, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SPONSOR (DEFINED BELOW) FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

OVERVIEW:

Salishan Wedding Contest (“Contest”) begins at 12:00:00 p.m. Eastern Time (“ET”) on July 27, 2018 and ends at 11:59:00 p.m. ET on Sunday, September 30, 2018 (“Contest Period”). Sponsor will invite entrants to enter the Contest via the Application (defined below) for a chance to win. The winner, subject to verification and compliance with these official rules, will be selected in a drawing from among eligible entries actually received by Sponsor as set forth in detail below. Prize does not include any ground transportation or travel.

ELIGIBILITY:

This Contest is open only to legal residents of any one (1) of the fifty (50) United States or the District of Columbia, who are at least twenty-one (21) years of age on the entry date and who are registered users of Facebook, Twitter, and/or Instagram in good standing on the date of entry in this Contest. Corporate entities are not eligible and have no right to claim any prize won by its employees. Employees, officers, directors, members, managers, agents, and representatives and family members of such individuals (or people living in the same household whether related or not) of Sponsor, Salishan Resort, or corporate partners, parent companies, divisions, subsidiaries, affiliates, successors in interest, advertising, promotion and public relations agencies (collectively, the “Contest Entities”) are not eligible to enter or win the prize. For the purposes of this Contest, family members are defined as spouse, partner, mother, father, legal guardian, in-laws, grandmother, grandfather, brother, sister, children and grandchildren. Participation in this Contest constitutes entrant’s full and unconditional agreement to and acceptance of these official rules and the decisions of Sponsor. This Contest is void outside the fifty (50) United States (including, without limitation, in all U.S. territories (including Puerto Rico), possessions and overseas military installations) and where prohibited by law.

TO ENTER:

During the Contest Period, eligible individuals can enter the Contest through the by following the instructions on the landing page (“Application”) or uploading directly on the accessible on the “Contest”. There is only (1) method of entry into the Contest. Eligible individuals must follow post instructions via the Application and complete/submit their entry via completing the form and uploading their photo and/or video the contest form. Fans may submit a photo or a :60 – 4-minute video as to why they should get married at the Salishan. Only entries that are recorded on the Contest’s servers will be considered. Other proof of submitting an entry (such as a printed or copied confirmation screen or message) does not constitute actual receipt of the entry for purposes of this Contest. Limit one (1) Entry per person per IP address per Contest. Attempts made by an individual to submit entries in excess of any limit or otherwise in violation of these Official Rules by using multiple or false contact information or otherwise may be

disqualified. All entries become the sole property of the Sponsor and receipt of entries will not be acknowledged or returned. Facsimiles, mechanical reproductions, alterations, garbled, incomplete, misdirected, lost, late, mutilated, or forged entries, or entries generated by a macro, bot, or other automated means will not be accepted and are void. Those who do not follow all of the instructions, provide the required information in their entry, or abide by these Official Rules will be disqualified. Entries made by any other individual or any entity, and/or originating at or using any other web site, including, without limitation, commercial promotion subscription notification and/or entering service sites, will be declared invalid and disqualified for this Contest. As a condition of entering the Contest, each entrant gives consent for Sponsor and its representative to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Contest and complying with applicable laws, regulations and rules. One (1) Prize Winner, subject to verification, will receive a prize, which consists of: the 100 guest wedding ceremony in the Glen and a Cedar Tree dinner reception (garden vegetable Crudit , Local and Imported Artisan Cheese Display, and a Chef Curated Buffet) at the Salishan Resort, 2-hour hosted wine and beer bar, day-of bridal makeup and hair (ARV \$15,000), 2-tier display cake, on-trend cupcakes for 100 guests and post dinner dessert (ARV \$550), 4-hour photo session with 500 downloadable images (ARV \$1,995), and flower arrangements (bridal bouquet, 3 bridesmaids bouquets, 3 boutonnieres, 10 table centerpieces (ARV \$2,000). A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR.”

ADDITIONAL DISCLAIMERS:

Released Parties are not responsible and/or liable for any of the following, whether caused by a Released Party, the entrant, or by human error: entries that are submitted by illegitimate means (such as, without limitation, by an automated computer program) or entries in excess of the stated limit; any
